You are invited to be a part of the **Downtown Lebanon 2010 Art Walk, Show and Sale.**

Art Walk July 22, 2010 with the Art Show continuing to October 31, 2010. This year's show is open to all Linn County Arts Guild members producing original works. Our goal at this year's show is for artists of Linn County Arts Guild to meet and make connections with other artists and art lovers within the Linn County community at large.

Artwork

Most artists will be able to show up to 10 pieces of work, depending on the size of each piece. Artwork may be for sale if you wish. Your name, the title of the piece, price and medium will be displayed under each work. No commission will be collected on sales.

Selection Process

Artists will submit three to four photographs or jpeg images on CD to be approved by the Merchants /Art Show Committee prior to the show. They need not be the work you plan to exhibit at the show, but must be similar in style and size. ***Please look at the spaces and decide where your work will be best suited. Applications are due no later than Friday, July 9, 2010.***

Rules, Regulations & Misc. Information

The 2010 Art Walk, Show and Sale is open to all Linn County Arts Guild members producing original works. Artists collaborating on work should so note on the application. Both artists must submit an application. Hand-pulled prints in numbered limited editions will be accepted as original works under the appropriate category. Commercially-produced work from kits, or imported art and goods shall not be permitted. The Linn County Arts Guild and the Merchants /Art Show Committee reserve the right to require removal of any such work or any work not approved by the Committee Members.
